# End User License Agreement

THIS END USER LICENSE AGREEMENT ("EULA") AND THE "ORDER" (AS DEFINED BELOW) CONTAIN THE ENTIRE AGREEMENT BETWEEN LEVI, RAY & SHOUP, INC. ("LICENSOR") AND YOUR COMPANY ("LICENSEE") WITH RESPECT TO THE LRS SOFTWARE PROGRAMS ACCOMPANYING THIS EULA OR FOR WHICH A LICENSE KEY IS PROVIDED ("SOFTWARE"). THE TERM "SOFTWARE" INCLUDES THE USER MANUAL AND TECHNICAL INFORMATION PERTAINING TO AND ACCOMPANYING THE SOFTWARE ("DOCUMENTATION"). READ THIS EULA CAREFULLY BEFORE CLICKING BELOW TO ACCEPT THE TERMS AND CONDITIONS OF THIS EULA. BY CLICKING TO ACCEPT AND DOWNLOADING AND/OR INSTALLING THE SOFTWARE, LICENSEE AGREES THAT (1) LICENSEE ACCEPTS AND AGREES TO BE BOUND BY THESE TERMS AND CONDITIONS, AND (2) YOU, THE INDIVIDUAL CLICKING TO ACCEPT, ARE AN EMPLOYEE OF THE LICENSEE AND AUTHORIZED TO ENTER INTO THIS EULA FOR AND ON BEHALF OF THE LICENSEE. IF LICENSEE DOES NOT AGREE WITH THESE TERMS AND CONDITIONS, CLICK THAT YOU DO NOT ACCEPT BELOW AND THE DOWNLOAD AND/OR INSTALLATION WILL TERMINATE.

- 1. Trial License. If Licensee is receiving the Software without having paid any license fees, you are receiving it as part of a non-exclusive, no charge, AS IS, thirty (30) day trial license starting from the date the temporary license key for the Software is first made available to Licensee. The trial period may be extended by Licensor at its sole discretion by sending a new license key. The trial license is subject to Licensee's strict compliance with all terms and conditions set forth in this EULA. Notwithstanding anything stated to the contrary, during the trial period, Licensee shall only use the Software for test or trial purposes. At the end of the trial period, or any extension, if Licensee does not enter into a license for production use, then Licensee shall destroy the Software (and all copies made). The Software is licensed for production use once the Licensee pays the applicable license fees and the production license key for Software is made available to Licensee. The Software, Other Programs (defined below), hardware and any services or support provided by Licensor to Licensee during the trial period are (unless delivered under a signed services agreement) provided "as is" without warranty, express or implied. If the Software requires prerequisite software, scripts or software code for your environment, or if the Software comes bundled with other products or code, Licensor will provide you such software, product(s) or code and any related documentation, (collectively "Other Programs"), and such Other Programs received shall be licensed under the terms the Software is licensed under this EULA.
- 2. Grant of License. Subject to payment of license fees and Licensee's strict compliance with all terms and conditions set forth in this EULA and the usage parameters in the Order, Licensor hereby grants to Licensee a non-exclusive, non-transferable, non-sublicensable license to use the Software for the license term stated in the Order. The Software may only be used by Licensee for Licensee's ordinary internal business purposes and those of its affiliates. It may not be used for the benefit of non-affiliated third parties unless specifically stated otherwise herein. Other license restrictions and usage parameters are described in Section 16 of this EULA and in the Order. For purposes of this EULA, the license term may be perpetual or for a specified limited term as indicated in the Order. "Order" means the purchase order, transaction document or other document(s) entered into between Licensee and Licensor or Licensor's authorized distributor or reseller to purchase licenses of the Software and/or maintenance and support for the Software.
- 3. Enhancements/Maintenance and Support. This EULA applies to improvements, fixes, modifications, changes, filters, or new releases or versions of the Software and any accompanying Documentation ("Enhancements") that Licensor makes generally available pursuant to maintenance and support services. Enhancements are included in the term "Software". Maintenance and support is automatically included in limited term licenses. For perpetual licenses, maintenance and support is purchased separately pursuant to an Order. The provision of maintenance and support services by Licensor to Licensee shall be governed by separate and independent LRS Maintenance Terms which can be found at <a href="https://www.lrsoutputmanagement.com/Support">https://www.lrsoutputmanagement.com/Support</a>. By ordering and paying LRS for maintenance and support, you accept and agree to the Maintenance Terms. If maintenance and support are purchased through an authorized reseller, such maintenance and support terms shall be between Licensee and such reseller.

4. Ownership and Restrictions. The Software is proprietary and is protected by U.S. and international copyright and other intellectual property laws and treaties. Licensee may not disclose or make available to third parties the Software, its Documentation or any portion thereof without Licensor's prior written approval, except that Licensee may allow its contractors access to the Software and Documentation to the extent necessary to allow the Licensee to use the Software or its computer systems effectively and provided that the contractors are contractually bound to obligations of nondisclosure. Licensor has the exclusive right to modify and enhance the Software and its Documentation, and the Licensee agrees that it will make no effort to reverse engineer, reverse assemble, decompile or otherwise attempt to derive source code from the Software except as expressly authorized by applicable law for purposes of achieving interoperability. All rights not expressly set forth herein are reserved to Licensor and its suppliers. No title or ownership of the Software is conferred with this license. This Software may not be copied except for the Licensee's backup or archival purposes.

## 5. Warranties, Disclaimers, Remedy.

- **5.1. Limited Warranty.** Once Licensee acquires a production license of the Software (as opposed to a trial license) pursuant to the terms of this EULA, Licensor warrants that the Software will function substantially in accordance with its Documentation for a period of one year from the date the production license key for the Software is first made available to Licensee ("Warranty Period"). This limited warranty does not apply during any trial period. The limited warranty for the Software expires at the end of the Warranty Period. The Warranty Period is not extended or renewed by renewal of a limited term license or by the purchase of additional license units of the Software.
- **5.2.** No Other Warranties. EXCEPT FOR THE LIMITED WARRANTY AND TO THE MAXIMUM EXTENT PERMITTED BY APPLICABLE LAW, LICENSOR PROVIDES THE SOFTWARE AS IS AND WITH ALL FAULTS, AND HEREBY DISCLAIMS ALL OTHER WARRANTIES, EITHER EXPRESS OR IMPLIED OR STATUTORY, INCLUDING WITHOUT LIMITATION, ANY WARRANTIES OF FITNESS FOR A PARTICULAR PURPOSE, MERCHANTABILITY OR ACCURACY. TO THE GREATEST EXTENT PERMITTED BY LAW, ANY IMPLIED WARRANTIES NOT EFFECTIVELY EXCLUDED BY THIS EULA ARE LIMITED TO NINETY (90) DAYS FROM THE DATE THE PRODUCTION LICENSE KEY FOR THE SOFTWARE IS FIRST MADE AVAILABLE TO LICENSEE OR THE MINIMUM PERIOD ALLOWED BY APPLICABLE LAW.
- **5.3.** Exclusive Remedy. DURING THE WARRANTY PERIOD, LICENSEE'S EXCLUSIVE AND SOLE REMEDY FOR BREACH OF WARRANTY IS LIMITED TO REPAIR OF DEFECTS, REPLACEMENT OF SOFTWARE, OR LICENSEE MAY TERMINATE THE LICENSE FOR THE SOFTWARE AND RECEIVE A REFUND OF LICENSE FEES RECEIVED BY LICENSOR FOR THE SOFTWARE DURING THE WARRANTY PERIOD.

#### 6. Limitation of Liability and Consequential Damages.

- 6.1. TO THE MAXIMUM EXTENT PERMITTED BY APPLICABLE LAW, IN NO EVENT SHALL LICENSOR OR ITS SUPPLIERS BE LIABLE FOR ANY INCIDENTAL, CONSEQUENTIAL, SPECIAL, PUNITIVE, OR INDIRECT DAMAGES OF ANY KIND (INCLUDING, WITHOUT LIMITATION, LOST PROFITS, LOSS OF DATA, LOSS OF USE, BUSINESS INTERRUPTION, OR CLAIMS OF THIRD PARTIES) ARISING OUT OF OR IN ANY WAY RELATED TO THE USE OF OR INABILITY TO USE THE SOFTWARE, THE PROVISION OF OR FAILURE TO PROVIDE MAINTENANCE AND SUPPORT SERVICES OR OTHERWISE IN CONNECTION WITH THIS EULA EVEN IF LICENSOR HAS BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGES.
- 6.2. TO THE MAXIMUM EXTENT PERMITTED BY APPLICABLE LAW AND SUBJECT TO SECTION 6.3, THE TOTAL LIABILITY OF LICENSOR FOR CLAIMS IN ANY WAY ARISING OUT OF OR IN CONNECTION WITH THIS EULA REGARDLESS OF THE FORM OF ACTION OR THEORYOF LIABILITY (INCLUDING CONTRACT, TORT OR WARRANTY), SHALL BE LIMITED TO THE LICENSE FEES RECEIVED BY LICENSOR FOR THE SOFTWARE DURING THE WARRANTY PERIOD. LICENSEE HAS READ THIS EULA AND UNDERSTANDS THAT IT IS A DOCUMENT WHICH HAS LEGAL CONSEQUENCES, INCLUDING THE LIMITING OF LIABILITY

FOR DAMAGES. AFTER DUE CONSIDERATION, LICENSEE AGREES THAT THE LIMITATION OF LIABILITY CLAUSE IS REASONABLE UNDER THE CIRCUMSTANCES.

- **6.3.** HOWEVER, BOTH PARTIES AGREE THAT NOTHING IN THIS EULA SHALL LIMIT IN ANY WAY THE LICENSOR'S LIABILITY OR DAMAGES FOR DEATH OR PERSONAL INJURY CAUSED BY INTENT OR NEGLIGENCE OF LICENSOR, FRAUDULENT CONCEALMENT OF A DEFECT, OR FRAUDULENT PRECONTRACTUAL MISREPRESENTATION BY LICENSOR RELIED UPON BY LICENSEE.
- 7. <u>Assignment.</u> This EULA may not be transferred or assigned to a third party without the written consent of Licensor except as otherwise allowed specifically by law. Any other attempted assignment or transfer shall be invalid and void.
- **8.** Termination. Either party may terminate this EULA before the expiration of the license term if the other party is in breach of this EULA and such party fails to remedy such breach within thirty (30) days after written notice thereof by the non-breaching party. Any termination of this EULA will automatically terminate any corresponding maintenance agreement that may have been entered into. There will be no refund of any fees paid upon a termination by Licensor pursuant to this section. Upon termination of this EULA, Licensee must immediately delete or otherwise destroy all copies of the applicable Software and Documentation other than copies which have been created pursuant to automatic archiving or back-up processes that cannot reasonably be deleted. Upon request, Licensee shall certify in writing to Licensor its compliance with this section within five (5) days after such request.
- **9.** <u>Notice.</u> Any questions concerning this EULA and any notice of any alleged breach or notice of filing of arbitration under this EULA shall be sent to Licensor at the following address:

- 10. Severability. If any provision of the EULA or the application of a provision to any party or circumstance is held invalid, the remainder of the EULA, or the application of the provision to a party or circumstances, other than those as to which it is held invalid, will not be affected. But if a court rules that any part of Section 4 or 7 is not enforceable because it is invalid, then the EULA in its entirety may be terminated at Licensor's option and Licensee must immediately destroy all copies, in whole or in part, of the Software and its Documentation. Under these circumstances, Licensee's obligation to pay future license fees will cease and any prepaid license fees will be refunded. In the case of a perpetual license, licensee fees will be refunded on a pro rata basis over a five (5) year life from the initial date the Software is licensed in production.
- 11. Applicable Law. This EULA and all disputes in connection with this EULA concerning its existence, validity, breach or termination whether during or after the license term, shall be resolved as follows. This EULA shall be governed by the laws of the State of Illinois, USA, without giving effect to its choice-of-law provisions, except that the parties agree that this EULA will not be governed by the provisions of the 1980 United Nations Convention on Contracts for the International Sale of Goods.
  - 11.1. If the Software is installed in the United States or Canada, Licensee irrevocably agrees to submit to the exclusive jurisdiction and venue of the state or federal courts in the State of Illinois in the event of any litigation involving this EULA or the Software. Licensee agrees that it shall not assert any claim that it is not subject to the jurisdiction of such courts, that the venue is improper, that the forum is inconvenient or any similar objection, claim or argument.
  - **11.2.** If the Software is installed in Mexico, Central America or South America, arbitration in accordance with Sections 11.6 and 11.7 shall take place in San Jose, Costa Rica.

- **11.3.** If the Software is installed in Europe, the Middle East or Africa, arbitration in accordance with Sections
- 11.6 and 11.7 shall take place in London, England.
- **11.4.** If the Software is installed in Australia, arbitration in accordance with Sections 11.6 and 11.7 shall take place in Sydney, Australia.
- **11.5.** If the Software is installed in Asia, arbitration in accordance with Sections 11.6 and 11.7 shall take place in Singapore.
- 11.6. All arbitration shall be binding in accordance with Arbitration Rules of the International Chamber of Commerce without recourse to ordinary courts of law except as otherwise stated in this Section 11.6 or 11.7. The arbitration proceeding will take place in the applicable location described above and be conducted in the English language. The arbitral award will be the exclusive remedy of the parties for all claims, counterclaims, issues or accountings presented or pleaded to the arbitrators except as set forth in Section 11.7. Judgment upon the arbitral award may be entered in any court that has jurisdiction thereof. Any additional costs, fees or expenses incurred in enforcing the arbitral award will be charged against the party that resists its enforcement. To the greatest extent allowed the parties agree that the prevailing party in the arbitration or allowed court proceedings shall have its attorney's fees paid by the non-prevailing party.
- 11.7. Nothing in this EULA will prevent Licensor from filing an action seeking injunctive relief and/or for non-payment of license fees against Licensee in any court of competent jurisdiction. Licensee acknowledges that, in the event Licensee breaches Sections 2, 4 or 7 of this EULA, Licensor will not have an adequate remedy in money or damages. Licensor shall therefore be entitled to obtain an injunction against such breach from the arbitrators or from any court of competent jurisdiction immediately upon request without posting bond. Licensor's right to obtain injunctive relief shall not limit its right to seek further remedies.
- **12.** <u>U.S. Government Contracts.</u> If the Software is licensed for use by the U.S. Government, the user agrees that the Software has been developed entirely at private expense and is delivered as "Commercial Computer Software" (as defined in DFARS 252.227-7013) or as "Restricted Computer Software" (as defined in FAR 52.227-19).
- 13. Export Compliance. Licensee agrees to comply fully with all relevant export laws and regulations of the United States, including but not limited to the U.S. Export Administration Regulations (collectively, "U.S. Export Controls"). Licensee expressly agrees that it shall not, and shall cause its representatives to agree not to export, directly or indirectly, re-export, divert, or transfer the Software and/or Documentation or direct product thereof to any destination or company restricted or prohibited by U.S. Export Controls.
- 14. Third Party Software. The software programs accompanying this EULA or for which a license key is provided, may include software programs under the licenses from third parties ("Third Party Software" and "Third Party License"). Any Third Party Software is licensed to Licensee subject to the terms and conditions of the corresponding Third Party License. Generally, the Third Party License is located in the Documentation. If the Third Party Licenses include licenses that provide for the availability of source code (such as the GNU General Public License) and the corresponding source code is not included with the Software, then contact Licensor support to learn how to obtain such source code. The term Software does not include Third Party Software for purposes of this EULA.
- **15. Final Agreement.** The EULA cannot be modified except by a written agreement signed by Licensor and Licensee. The terms and conditions contained or referenced in any purchase order, request for proposal, acknowledgment or other business form submitted in connection with the subject matter of this EULA shall not have any effect on the rights, duties or obligations of the parties hereunder, nor otherwise modify this EULA, regardless of any failure of Licensor to object to such terms and conditions.

### **16.** Software License Restrictions. Additional Software license restrictions are set forth below:

The quantity of printers and/or users, devices and/or workstations as applicable, the host name and operating system of each server upon which the Software is installed, and any other applicable license restrictions shall be set forth in the Order. There are technological measures in the Software that are designed to enforce the license restrictions stated in this EULA and the Order and, for server-based Software, enable usage on the designated server. Licensee agrees that Licensor may use those measures, and that Licensee will not attempt to circumvent such measures.

The Software may also contain a mechanism that will cause the Software to cease to operate on a date set by the Licensor. Licensee will be provided short term license keys to allow for payment of license fees and upon payment Licensee will be supplied with the necessary license files and/or product keys to extend the date mechanism. For limited term licenses the key(s) will be extended through the next payment date. Neither Licensor nor its authorized resellers or distributors has remote access to the Software.

Upon prior written notice Licensee may change the address of the facility where the Software is installed within the country where the Software was originally licensed. Licensee may not transfer or export the Software to another country without Licensor's prior written consent. No more than annually, upon request Licensee shall allow Licensor to have access to Licensee facility(ies) and/or records as may be reasonably required to determine compliance with this EULA.

In addition to the license restrictions above, the following product-specific restrictions apply to the named Software products.

For purposes of these Software License Restrictions, the term "VPSX Software" means VPSX Enterprise and all products with the VPSX prefix other than VPSX fonts products.

VPSX/SecureDelivery, Mobile Connector for VPSX®, VPSX/KeI, VPSX/MI, VPSX/DPE, VPSX/MFI software is licensed by number of definitions of printers/output devices ("supported printer"). Note this is not total number of physical output devices but rather total number of printer definitions. If it is used on more than one server, the supported printers shall be allocated among the servers. The Software may be installed on an unlimited number of servers limited to a single installation location.

## Transform Software, Innovate/Mill®

This Software is licensed either by number of printers or dedicated users depending upon whether the Transform is viewable or printable. Transform software may only be installed on the same server(s) as the VPSX Software and/or PageCenterX<sup>®</sup>.

### PageCenterX®

This Software is licensed by number of concurrent users. The number of users licensed is the maximum number of individuals that may use the Software at one time. Licensed users authorized by Licensee may be third parties provided such licensed users shall only have access to the PageCenterX Software via a web browser and shall have no access to the object code or Documentation. The Software may be installed on an unlimited number of servers limited to a single installation location.

#### PageCenterX/Satellite Bundle

The PageCenterX Software is licensed as set forth above, and PageCenterX/Satellite is licensed by number of workstations on which the PageCenterX/Satellite software may be installed and registered to PageCenterX. The PageCenterX Software may be installed on an unlimited number of servers limited to a single installation location, and the PageCenterX/Satellite software may be installed outside of the installation location as long as it is installed within the same country.

# Intelligent Document Bundling for VPSX®, Virtual Session Printer Agent for VPSX®, PDDT, VPSX/DBCS Fonts, VPSX/Global Fonts

This Software is licensed by site. The Software may be installed on an unlimited number of servers limited to a single installation location which must be the same installation location in which VPSX Software is installed.

#### **Affiliate Print**

This feature can be utilized with VPSX Enterprise<sup>®</sup>, VPSX/Workplace<sup>®</sup>, VPSX/OutputManager<sup>®</sup>,

**VPSX/EI, VPSX/MI, VPSX/DPE, VPSX/MFI and Mobile Connector for VPSX**<sup>®</sup>. This feature may be used by and for third parties subject to the applicable Affiliate Print EULA. Licensee agrees that any act or omission by such third party to which Licensee provides the Software that would be considered a breach or violation of this EULA if committed by Licensee shall be deemed a breach by Licensee for purposes of this EULA.

#### **PPM Local Delivery**

This Software is licensed by number of named users. The number of users licensed is the maximum number of individuals that may use the Software.

MFPsecure®/Print, MFPsecure®/Scan and MFPsecure®/Scan Pro software is licensed by number of physical output devices that may be used with the software. VPSX/Secure Delivery is automatically licensed without charge for an equal number of devices as the number licensed for MFPsecure/Print. MFPsecure/Print for XT requires RF-XT Kit. A license for MFPsecure/Print, MFPsecure/Scan or MFPsecure/Scan Pro is tied to a platform for a particular printer manufacturer so that it may operate with that manufacturer's printers. At no additional cost, the licensed platform may be exchanged for another platform of equal or lesser price. The licensed platform may be exchanged for a platform with a greater price upon payment of additional license fees calculated as the delta between fees paid for the licensed platform and the then current fees for the new platform in the case of a perpetual license. In the case of a limited term license, the additional license fees will be prorated over the remainder of any prepaid annual period and thereafter the annual fees will increase for the remainder of the license term.
